INSTANT INVOICE SOFTWARE LICENSE AGREEMENT

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE SOFTWARE. INSTANT INVOICE IS A PRODUCT OF COTEK SYSTEM, INC.

BY INSTALLING, OPENING THE PACKAGE, DOWNLOADING THE PRODUCT, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, RETURN THE PRODUCT TO THE PLACE OF PURCHASE FOR A FULL REFUND, OR DO NOT DOWNLOAD THE PRODUCT AND DO NOT INSTALL IT.

Free Site License: *Cotek Systems, Inc and its suppliers grant to Customer ("Customer") a nonexclusive and nontransferable license to use the Instant Invoice Add-in ("Software") in object code form solely on a single site with 3 invoices created by Customer per month or otherwise embedded in app file or wsp file provided by Cotek Systems, Inc.*

Standard Site License: *Cotek Systems, Inc and its suppliers grant to Customer ("Customer") a nonexclusive and nontransferable license to use the Instant Invoice Add-in ("Software") in object code form solely on a single site with 30 invoices by Customer per month or otherwise embedded in app file or wsp file provided by Cotek Systems, Inc.*

Premium Site License: *Cotek Systems, Inc and its suppliers grant to Customer ("Customer") a nonexclusive and nontransferable license to use the Instant Invoice Add-in ("Software") in object code form solely on a single site with 1000 invoices created by Customer per month or otherwise embedded in app file or wsp file provided by Cotek Systems, Inc.*

Professional License: *Cotek Systems, Inc and its suppliers grant to Customer ("Customer") a nonexclusive and nontransferable license to use the Instant Invoice Pro Add-in in object code form:*

- (i) installed on one site with an unlimited number of Catalog items on a single site by Customer for which Customer has paid a license fee ("Permitted Number of Licenses"); or*
- (ii) provided the Software is configured for network use, installed on an unlimited number of servers for use on a single local area network for either (but not both) of the following purposes:*
 - a. permanent installation onto a hard disk or other storage device of up to the Permitted Number of Computers; or*
 - b. use of the Software over such network, provided the number of computers connected to the server does not exceed the Permitted Number of Computers.*

Customer may only use the programs contained in the Software

- (i) *for which Customer has paid a license fee (or in the case of an evaluation copy, those programs Customer is authorized to evaluate) and*
- (ii) *for which Customer has received a product authorization key from store.cotekinc.com or Microsoft Office 365 store. Customer grants to Cotek Systems, Inc or its independent accountants right to examine its site during Customer's normal business hours to verify compliance with the above provisions.*
- (iii) *In the event such audit discloses that the Permitted Number of site is exceeded, Customer shall promptly pay to Cotek Systems, Inc the appropriate licensee fee for the additional sites or users. At Cotek Systems, Inc 's option, Cotek Systems, Inc may terminate this license for failure to pay the required license fee.*

Customer may make one (1) archival copy of the Software provided Customer affixes to such copy all copyright, confidentiality, and proprietary notices that appear on the original.

EXCEPT AS EXPRESSLY AUTHORIZED ABOVE, CUSTOMER SHALL NOT: COPY, IN WHOLE OR IN PART, SOFTWARE OR DOCUMENTATION; MODIFY THE SOFTWARE; REVERSE COMPILE OR REVERSE ASSEMBLE ALL OR ANY PORTION OF THE SOFTWARE; OR RENT, LEASE, DISTRIBUTE, SELL, OR CREATE DERIVATIVE WORKS OF THE SOFTWARE.

Customer agrees that aspects of the licensed materials, including the specific design and structure of individual programs, constitute trade secrets and/or copyrighted material of Cotek Systems, Inc. Customer agrees not to disclose, provide, or otherwise make available such trade secrets or copyrighted material in any form to any third party without the prior written consent of Cotek Systems, Inc. Customer agrees to implement reasonable security measures to protect such trade secrets and copyrighted material. Title to Software and documentation shall remain solely with Cotek Systems, Inc.

LIMITED WARRANTY. *Cotek Systems, Inc warrants that for a period of (30) days from the date of install from either Office 365 or Instant Invoice.com:*

- (i) *the media on which the Software is furnished will be free of defects in materials and workmanship under normal use; and*
- (ii) *the Software substantially conforms to its published specifications. Except for the foregoing, the Software is provided AS IS. This limited warranty extends only to Customer as the original licensee. Customer's exclusive remedy and the entire liability of Cotek Systems, Inc and its suppliers under this limited warranty will be, at Cotek Systems, Inc or its development center's option, repair, replacement, or refund of the Software if reported (or, upon request, returned) to the party supplying the Software to*

Customer. In no event does
