

## BULLETPROOF END USER LICENSE AND SUBSCRIPTION AGREEMENT

For

BULLETPROOF APPS

Last Updated: February 12, 2018

This Bulletproof End User License and Subscription Agreement ("Agreement") is made by and between You (as defined below) and Bulletproof Solutions ("Bulletproof" which may also be referred to in this Agreement as "we", "us" and "our"). This Agreement constitutes a binding contract between You and Bulletproof (together, the "Parties" and individually, each a "Party").

THIS AGREEMENT IS EXPRESSLY CONDITIONED UPON THE FOLLOWING TERMS AND CONDITIONS. ANY ADDITIONAL OR DIFFERENT TERMS OR CONDITIONS IN ANY FORM DELIVERED BY YOU OR ON YOUR BEHALF ARE HEREBY DEEMED TO BE MATERIAL ALTERATIONS, AND NOTICE OF OBJECTION TO THEM AND REJECTION OF THEM IS HEREBY GIVEN. ANY ADDITIONAL OR DIFFERENT TERMS OR CONDITIONS ARE HEREBY SUPERSEDED BY, AND NOT A PART OF, THIS AGREEMENT, AND ARE NOT BINDING UPON THE PARTIES.

YOU WILL HAVE ACCEPTED THIS AGREEMENT IF YOU: 1) ACCESS, SUBSCRIBE TO, OR USE THE BULLETPROOF SOFTWARE; OR 2) CLICK THE "I ACCEPT" OR SIMILAR BUTTON INDICATING AGREEMENT ASSOCIATED WITH THIS AGREEMENT.

IF YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF A CORPORATION, PARTNERSHIP, COMPANY OR ANY OTHER ENTITY, YOU HEREBY REPRESENT AND WARRANT TO BULLETPROOF THAT YOU ARE AUTHORIZED TO ENTER INTO THIS AGREEMENT ON BEHALF OF AND BIND THE ENTITY TO THE TERMS AND CONDITIONS CONTAINED HEREIN.

BULLETPROOF IS WILLING TO ALLOW THE LICENSE AND YOUR ACCESS AND USE OF THE BULLETPROOF SOFTWARE ONLY UPON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS AGREEMENT. BY ACCEPTING THIS AGREEMENT YOU ARE BINDING YOURSELF TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, THEN BULLETPROOF IS UNWILLING TO ALLOW THE LICENSE OF THE BULLETPROOF SOFTWARE AND YOU MUST NOT ACCESS OR USE THE BULLETPROOF SOFTWARE.

- 1. CERTAIN DEFINITIONS. In addition to other terms that are defined as set forth in this Agreement, the following terms shall have the following definitions:
  - 1.1. "Device" means Your computer, tablet, smartphone, or any other electronic device.
  - 1.2. "Intellectual Property" means any and all of the following in any jurisdiction throughout the world and all rights in, arising out of, or associated therewith: (a) patents, utility models, and applications therefor, and all reissues, divisions, reexaminations, renewals, extensions, provisionals, continuations and continuations-inpart thereof, and equivalent or similar rights anywhere in the world in inventions and discoveries, including invention disclosures; (b) all trade secrets, inventions (whether or not patentable and whether or not reduced to practice), and other rights in know-how and confidential or proprietary information; (c) all mask works, works of authorship and copyrights, registrations and applications therefor, and all other rights corresponding thereto (including moral rights), throughout the world; (d) rights in software (including without limitation APIs, source code, object code, and mark-up language); (e) rights of publicity, personality, identification, or similar personal or group attributes; (f) trade names, logos, common law trademarks and service marks, trade dress, trademark and

- service mark registrations, and applications therefor and any goodwill associated therewith; and (g) any similar, corresponding, or equivalent rights to any of the foregoing and any other intellectual property or proprietary rights throughout the world.
- 1.3. "Bulletproof Software" means any Bulletproof Apps for SharePoint that you have downloaded and installed. These Apps are more fully described at their associated Microsoft AppSource product page, its content, documentation, and all Intellectual Property in and related thereto, all of which is offered on a software as a service ("SaaS") basis.
- 1.4. "Modifications" means additional or modified functionality (including the removal of functionality), updates, enhancements, security updates and patches, and upgrades to Bulletproof Software.
- 1.5. "Users" means each individual user of the Bulletproof Software.
- 1.6. "You" and "Your" refer to any person or entity acquiring or using under the terms of this Agreement the Bulletproof Software and supporting documentation. In this Agreement, "You" and "Your" refer collectively to you, the customer, and any corporation, partnership, company or other entity you represent.
- 2. LICENSE. Unless otherwise noted in this Agreement, and to the fullest extent allowed under any applicable laws, all terms and conditions of this Agreement apply to the license and Your access and use of any and all Bulletproof Software. Bulletproof Software is provided as an App for SharePoint and operates within the SharePoint Online environment provided by Microsoft Office 365 cloud services, and therefore Your license to the Bulletproof Software is contingent upon Microsoft continuing to offer such services and Your continued compliance with Microsoft's relevant licensing terms and conditions for such services.
  - 2.1. GRANT OF LICENSE. Conditioned upon Your compliance with the terms and conditions of this Agreement, Bulletproof grants to You a non-exclusive, non-transferable license to access and use the Bulletproof Software solely for Your internal use during the term of Your subscription and subject to the user count limit and payment of associated fees for the subscription level You have chosen.
  - 2.2. THIRD PARTY SOFTWARE. You acknowledge that Bulletproof may have incorporated into the Bulletproof Software Intellectual Property created by third parties ("Third Party Intellectual Property"), and You agree that Your right to use the Bulletproof Software containing Third Party Intellectual Property may be subject to the rights of third parties and limited by agreements with such third parties. The Bulletproof Software may also display, include, or make available third party content (including data, information, applications, and other products, services, and/or materials) or provide links to third

party websites or services, including through third party advertising ("Third Party Materials"). You acknowledge and agree that Bulletproof is not responsible for Third Party Materials, including their accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality, or any other aspect thereof. Bulletproof does not assume and will not have any liability or responsibility to You or any other person or entity for any Third Party Materials. Third Party Materials and links thereto are provided solely as a convenience to You, and You access and use them entirely at Your own risk and subject to such third parties' terms and conditions.

- 2.3. TITLE AND OWNERSHIP. Title to and ownership of the Bulletproof Software and all copies thereof remain with Bulletproof and any other licensor(s) of the same, regardless of the form or media in or on which they may exist, and You agree to protect all of Bulletproof's ownership interests therein. This is a license to the Bulletproof Software during the term of any Evaluation Period and for any time period of Your subscription. You are granted no implied licenses to any other Intellectual Property rights other than as specifically granted herein. You acknowledge that the Bulletproof Software contains trade secrets of Bulletproof, its suppliers, or licensors, including but not limited to, the specific internal design and structure of individual programs and associated interface information, and other content accessed within the Bulletproof Software. All rights not expressly granted in this Agreement are reserved by Bulletproof. You represent and warrant that (a) You are the owner or an authorized user of the Device on which the Bulletproof Software is to be accessed and used, and that Your use of the Bulletproof Software and all data You provide in relation to the Bulletproof Software will comply with all applicable federal, state, province, and local laws and regulations applicable to the use of the same.
- 3. LICENSE RESTRICTIONS. You will not and You will not permit or assist, directly or indirectly, any User or other entity or individual to:
  - 3.1. transfer, assign, rent, lease, lend, or sublicense Your subscription license to another person or entity and You acknowledge that any such transfer, assignment, rental, leasing, lending, or sublicense shall be void;
  - 3.2. make error corrections to, or otherwise modify or adapt, the Bulletproof Software or to create derivative works based upon the Bulletproof Software or permit third parties to do the same;
  - 3.3. reverse engineer, decrypt, disassemble, decompile or otherwise attempt to derive the source code of the Bulletproof Software, except where expressly permitted under applicable law notwithstanding this restriction;
  - 3.4. perform, display, or otherwise access or use the Bulletproof Software for the benefit of others or to provide services or make available to others whether on a service bureau or time sharing basis or otherwise;

- 3.5. access or use the Bulletproof Software Services to develop any software application or similar products and services;
- 3.6. train persons other than Your Users; or
- 3.7. access or use all or any portion of the Bulletproof Software in any manner that is inconsistent with the terms of this Agreement or in violation of any applicable law or regulation.
- 4. SUPPORT SERVICES. In addition to the support services detailed below, SharePoint support and other services are available. For more information, go to <a href="https://www.bulletproofsi.com/services/">https://www.bulletproofsi.com/services/</a>.
  - 4.1. SUPPORT FOR FREE LICENSE. When You are using a free license for the Bulletproof Software, You may contact Bulletproof Support. Bulletproof Support will reply to email and online form requests from You; however, no response time is guaranteed for Evaluation Licenses. You may contact Bulletproof support by phone; however, additional charges may apply. You may contact Bulletproof support to report any error or issue with the App. If Bulletproof determines that the error or issue is a genuine defect in the Bulletproof Software or caused by changes to Office 365 SharePoint Online, Bulletproof may fix the defect, in its sole discretion and at no cost to You.
  - 4.2. SUPPORT DURING THE PAID SUBSCRIPTION LICENSE. When You are using a paid subscription license for the Bulletproof Software:
    - 4.2.1. Bulletproof support will use commercially reasonable efforts to reply to email and online form requests within two (2) business days;
    - 4.2.2. Bulletproof support will use commercially reasonable efforts to assist with the initial setup of the Bulletproof Software, by phone or by email, at no cost to You;
    - 4.2.3. You may contact Bulletproof support by phone; however, additional charges may apply for requests beyond the initial setup of the Bulletproof Software; and
    - 4.2.4. You may contact Bulletproof support to report any error or issue with the Bulletproof Software. If Bulletproof determines that the error or issue is a genuine defect in the Bulletproof Software or caused by changes to Office 365 SharePoint Online, Bulletproof will use commercially reasonable efforts to fix the defect at no cost to You.
- 5. MAINTENANCE AND UPGRADES. You acknowledge that the Bulletproof Software subscription is purchased separately from any subscription to future upgrades, updates and fixes to it, and You are not entitled to any of the same or any additional software maintenance services except as expressly stated under this Agreement. Nothing herein shall prevent You and Bulletproof from entering into a separate agreement regarding such upgrades, updates, fixes, additional maintenance services or other service provided by

Bulletproof, and to the extent Bulletproof supplies any Modifications to You through Your existing subscription without a separate agreement, such Modifications shall be subject to the rights and obligations, including without limitation the license and license restrictions, set forth in this Agreement. Modifications may also modify or delete in their entirety certain features and functionality of the Bulletproof Software. You agree that Bulletproof has no obligation to provide any Modifications or to continue to provide or enable any particular features or functionality of the Bulletproof Software.

6. CONSENT FOR INTERNET-BASED OR WIRELESS SERVICES. Bulletproof Software will connect to Microsoft Azure cloud services over an Internet-based and/or wireless network. You will not receive a separate notice when they connect, although You may notice that the web address in Your web browser has changed from Your SharePoint site to the Bulletproof Software website in Microsoft Azure. Using the Bulletproof Software operates as Your consent to the transmission of standard device information (including, but not limited, to technical information about Your device, system and Bulletproof Software, and peripherals) for Internet-based and/or wireless services.

## 7. CONFIDENTIALITY AND FEEDBACK.

7.1. CONFIDENTIALITY. The Bulletproof Software and its and its content, including, but not limited to, source and object code, logic and structure, and any and all copies of the foregoing, regardless of the form or media in or on which any of them may exist (all together, the "Confidential Information") constitute valuable trade secrets, are the Intellectual Property and confidential information of Bulletproof and any other of their licensor(s), and are protected by copyright and intellectual property laws, international treaty provisions, and applicable laws of the country in which such Confidential Information is being used. Confidential Information additionally includes non-public information disclosed by Bulletproof if it is clearly and conspicuously marked as "confidential" or with a similar designation at time of disclosure or non-public information disclosed by Bulletproof if, by its nature, would generally be considered by Bulletproof to be confidential. Confidential Information shall not include information which: (i) is or becomes public knowledge through no fault of You; (ii) was in Your possession before receipt from Bulletproof; (iii) is rightfully received by You from a third party without any duty of confidentiality; (iv) is disclosed to a third party by Bulletproof without a duty of confidentiality on the third party; (v) is independently developed by You; or (vi) is disclosed with the prior written approval Bulletproof. Disclosures of Confidential Information will be restricted to those individuals who are participating in the performance of this Agreement and who need to know such Confidential Information for purposes of receiving and/or using the Confidential Information in a way expressly permitted by this Agreement. Confidential Information of Bulletproof may be disclosed in response to a valid court order or other legal process only to the extent required by such order or process and only after You have given

Bulletproof written notice, if legally allowed, of such court order or other legal process promptly and the opportunity for Bulletproof to seek a protective order or confidential treatment of such Confidential Information, at Bulletproof's expense, with reasonable cooperation by You. Bulletproof shall retain all ownership of its Confidential Information including without limitation all Intellectual Property rights in that Confidential Information. Subject to the licenses granted in this Agreement, You agree, both during the term of the Agreement and after the termination of the Agreement to hold Bulletproof Confidential Information in confidence and to protect the disclosed Confidential Information by using the same degree of care to prevent the unauthorized use, dissemination or publication of the Confidential Information as You use to protect Your own Confidential Information of a like nature but in no event with less than reasonable care. You shall be responsible and liable under the terms of this Agreement for any violation of the confidentiality requirements of this Section committed by Your employees, agents, representatives, or independent contractors.

- 7.2. FEEDBACK. You may provide feedback to Bulletproof with respect to the Bulletproof Software. Notwithstanding any provision of the Agreement to the contrary, Bulletproof may use such feedback for any purpose without obligation of any kind, including without limitation any confidentiality obligations to You. You hereby assign to Bulletproof all right title, and interest in any feedback You provide to Bulletproof including all Intellectual Property in and related thereto.
- 8. DEVICE RESPONSIBILITY. In order to use the Bulletproof Software, You must provide all Devices, equipment and software necessary to use Bulletproof Software, including, but not limited to, a suitably fast Internet connection, a compatible browser, and a Device that is in working order and that is suitable for use in connection with the Bulletproof Software. You are responsible for ensuring that Your Device, equipment and/or software do not disturb or interfere with Bulletproof operations or the operations of other users of the Bulletproof Software or any third party data or systems. If any Modification to the Bulletproof Software requires changes in Your Device, Internet connection, equipment or software, You must effect these changes at Your own expense.
- 9. ACCOUNT DETAILS AND CREDENTIALS. You agree to keep all account details and credentials private and to not share them with anyone else in order to prevent unauthorized access to Your account, Your password, and other login credentials (if any) and Your data. Your administrator for the Bulletproof Software is responsible for creating and providing login credentials, if applicable, for all authorized Users. Bulletproof is not liable for any loss or damage arising from any access to, sharing or use of Your account, Your password or other credentials, or Your data, whether at the administrator account level or otherwise. You are solely responsible for any use of the Bulletproof Software using Your account and/or Your password and other login credentials.

10. PROPRIETARY NOTICES. You agree to maintain and reproduce all copyright, patent, trademark and other proprietary notices related to the Bulletproof Software in the same form and manner that such copyright and other proprietary notices are included on the Bulletproof Software.

- 11.1. or by contacting Bulletproof sales representatives ("Pricing Policy"). Bulletproof may change the price for the Bulletproof Software from time to time by updating the Pricing Policy. Such changed price will take effect after the expiry of the then current paid for period (i.e. the subscription term that You have already paid for). If You do not wish to be bound by such changed price relating to Your Bulletproof Software, You may terminate Your subscription of in accordance with the Termination section of this Agreement. Your continued access and use of the Bulletproof Software after any change in the Pricing Policy constitutes an acceptance of such new price.
- 11.2. PAYMENT TERMS. BY ACCEPTING THIS AGREEMENT AND ACCESSING OR USING BULLETPROOF SOFTWARE, YOU EXPRESSLY AUTHORIZE BULLETPROOF AND/OR MICROSOFT TO BILL AND COLLECT PAYMENT FROM YOU BY ANY PAYMENT METHOD YOU REGISTER WITH BULLETPROOF AND/OR MICROSOFT INCLUDING, BUT NOT LIMITED TO, YOUR CREDIT CARD, BANK ACCOUNT, OR ONLINE PAYMENT SYSTEM SUCH AS PAYPAL. All prices stated in relation to the Bulletproof Software are exclusive of any applicable sales taxes and fees and are subject to change at any time, as set forth in this Agreement. It is Your responsibility to maintain proper payment and billing information with Bulletproof and/or Microsoft. Failure to maintain proper and up-to-date payment and billing information will result in the termination of Your license and subscription to the Bulletproof Software at the end of Your then-current subscription period in accordance with the Termination section of this Agreement. Your subscription to the Bulletproof Software You purchase will automatically renew at the end of each billing cycle at the then current fees unless You terminate Your subscription prior to the end of such billing cycle in accordance with the Termination section of this Agreement. Unless You log into Your account to designate otherwise, such renewal will always be for Your prior subscription term and at Your prior subscription level (e.g., number of Users). At the time of renewal the payment method You have designated to be charged for the subscription of the Bulletproof Software will automatically be charged our then current fees for the applicable subscription.

- 11.3. REFUNDS. If You purchase a Paid Subscription License and You are not satisfied, You may request a refund within thirty (30) days of purchase. If Your request is received and approved by Bulletproof within the first thirty (30) days, Bulletproof will refund the entire amount of Your subscription. Bulletproof is not otherwise obligated to refund any payments already paid except as stated in the Termination section of this Agreement, and any cancellation by You will take place at the end of Your applicable subscription term.
- 12. TERM AND TERMINATION. This Agreement shall be effective as of Your acceptance of this Agreement and shall continue in effect until terminated as set forth in this Agreement. Bulletproof may, at its election and in its sole discretion, terminate this Agreement and any subscription to the Bulletproof Software at will, and if Bulletproof does terminate this Agreement for its convenience and not due to Your breach, Bulletproof will refund any prepaid fees for any unused portion of the then applicable subscription term. Bulletproof specifically and without limitation reserves the right to terminate this Agreement and Your use of Bulletproof Software, and/or suspend Your use of the Bulletproof Software, immediately, without notice from Bulletproof and without any refund of prepaid fees, if: (i) You fail to comply with any provision of this Agreement; (ii) You use any Bulletproof Software in a way not intended by Bulletproof; or (iii) You abuse Your use of Bulletproof Software including without limitation engage in any DNS attack, attempt to circumvent or exceed security measures, engage in fraud, violate any applicable laws or regulations, or otherwise engage in suspicious activities. Bulletproof is further entitled to obtain injunctive relief if Your use of the Bulletproof Software is in violation of any restrictions set forth in this Agreement, including without limitation any license restrictions. You may also terminate this Agreement for Bulletproof's breach of this Agreement provided that Bulletproof fails to cure such breach after You have given Bulletproof written notice of the breach and an opportunity to cure the breach within thirty (30) days of the notice. The termination of this Agreement for any reason shall not affect: a) except as set forth herein, the obligations of You to account for and pay to Bulletproof any amounts for which You are obligated by virtue of transactions or events which occurred prior to the effective date of termination; or b) any other obligation or liability which either Party has to the other under this Agreement and which, by its nature, would reasonably be expected to survive termination. Upon termination of the license under this Agreement for any reason, You shall immediately cease using the Bulletproof Confidential Information, and You shall (i) cease accessing and using the Bulletproof Software and destroy any copies of Bulletproof documentation in Your possession or control, (ii) return the Confidential Information to Bulletproof, and (iii) at Bulletproof's request, provide Bulletproof with certification from a principal officer of Your organization that You have complied in full with this Termination section of the Agreement. You acknowledge and agree that Bulletproof reserves the right to remotely prevent access to and/or use of the Bulletproof Software, including without limitation by withholding keys or other information necessary for its operation, in the

- event that (i) Bulletproof becomes aware, from You or otherwise, of unauthorized access or use of the Bulletproof Software, or (ii) Your violation of any term or condition of this Agreement. Bulletproof Software and Your access and use thereof may be monitored by Bulletproof to verify the status of any subscription and right to use the Bulletproof Software, as well as Your compliance with this Agreement and Bulletproof's contractual and intellectual property rights, and Your compliance with the law. Devices used to access the Bulletproof Software may also be tracked by Bulletproof (such as via Internet Protocol address and other log information regarding the device, its operating system, browser, and other information) to identify the Device and locate where on the Internet that computer is located.

Bulletproof HEREBY EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTY OF TITLE, ACCURACY, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT. to the fullest extent allowed by law, You expressly waive any claim that You may have against Bulletproof based on any product liability or infringement or alleged infringement of any patent, copyright, trademark, trade secret, or other intellectual property rights with respect to the BULLETPROOF software and also waive any right to indemnification from Bulletproof against any such Claim made against You by a third party. You acknowledge that no employee of Bulletproof is authorized to make any representation or warranty on behalf of Bulletproof that is not in this Agreement. You acknowledge and agree that Bulletproof has set its prices and entered into this Agreement and Your subscription to the Bulletproof Software in reliance upon the disclaimers of warranty and the limitations of liability set forth herein, that the same reflect an allocation of risk between the Parties (including the risk that a contract remedy may fail of its essential purpose and cause consequential loss), and that the same form an essential basis of the bargain between the Parties. IN THE EVENT OF ANY LIABILITY INCURRED BY BULLETPROOF. BULLETPROOF'S AGGREGATE AND CUMULATIVE LIABILITY FOR DAMAGES FROM ANY CAUSE WHATSOEVER RELATED TO THE BULLETPROOF SOFTWARE OR ARISING OUT OF OR RELATING TO THIS AGREEMENT WILL IN NO EVENT EXCEED THE DOLLAR AMOUNT PAID BY YOU DURING THE TWELVE (12) MONTHS PRECEDING THE EVENT GIVING RISE TO THE CLAIM FOR DAMAGES.

- 15. INDEMNITY BY YOU. You will, to the fullest extent permitted by law, indemnify Bulletproof and its officers, directors, shareholders, members, parent companies, subsidiaries, employees and agents and their respective successors and assigns (collectively, the "Bulletproof Indemnified Parties") against and hold the Bulletproof Indemnified Parties harmless from any and all claims, liabilities, losses, damages, judgments, awards, costs and expenses, including reasonable expert and attorneys' fees in connection with investigating, defending, and settling any claim relating to or arising out of any acts or omissions on the part of You which are a breach of this Agreement or give rise to claims against Bulletproof Indemnified Parties by third parties in relation to Your accessing or using the Bulletproof Software, excluding any claim to the extent due to the negligent or intentionally wrongful acts of Bulletproof.
- 16. GENERAL. This Agreement contains the entire understanding of the Parties with respect to the matters contained herein and supersedes and replaces in its entirety any and all other prior and contemporaneous agreements and understandings, whether oral, written, electronic or implied between Bulletproof and You with respect to the Bulletproof Software, and/or any other subject matter hereof. No course of prior dealings between the Parties and no usage of trade will be relevant to determine the meaning of this Agreement. No provision of this Agreement will be deemed waived, amended or modified by Bulletproof unless such waiver, amendment or modification is made by an officer of Bulletproof in a signed written document. No valid waiver or consent will be construed as a waiver of or consent to subsequent acts or failures to act. Any delay or failure by either Party to exercise any right or remedy will not constitute a waiver of that Party to thereafter enforce such rights. The section headings appearing in this Agreement are inserted only as a matter of convenience and in no way define, limit, construe or describe the scope or

extent of such section or in any way affect such section. Bulletproof may assign and/or subcontract all or any portion of its rights and/or obligations under this Agreement and/or assign the right to receive payments, without Your consent. You may not assign this Agreement or any of its rights or obligations herein except to the extent permitted by an officer of Bulletproof in a signed written document. Subject to such restriction on assignment, this Agreement will be binding on and inure to the benefit of the Parties hereto and their successors and assigns. Except for the Bulletproof Indemnified Parties, no third party beneficiaries are intended or shall be construed as created by virtue of this Agreement. Electronic signatures (or copies of signatures sent via electronic means) are the equivalent of written and signed documents. If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, illegal or otherwise unenforceable, the same shall not affect the other terms or conditions hereof or the whole of this Agreement. This Agreement describes certain legal rights. You may have other rights under the laws of the state, province, or country where You reside. This agreement does not change Your rights under the laws of the state, province, or country where You reside if such laws do not permit it to do so. THIS AGREEMENT AND ALL CLAIMS OR CAUSES OF ACTION (WHETHER IN CONTRACT, TORT, OR STATUTE) THAT MAY BE BASED UPON, ARISE OUT OF, OR RELATE TO THIS AGREEMENT, OR THE NEGOTIATION, EXECUTION, OR PERFORMANCE OF THIS AGREEMENT (INCLUDING ANY CLAIM OR CAUSE OF ACTION BASED UPON, ARISING OUT OF, OR RELATED TO ANY REPRESENTATION OR WARRANTY MADE IN OR IN CONNECTION WITH THIS AGREEMENT) OR AS AN INDUCEMENT TO ENTER INTO THIS AGREEMENT, AND YOUR USE OF THE BULLETPROOF SOFTWARE, SHALL BE GOVERNED BY THE LAWS OF THE PROVINCE OF NEW BRUNSWICK, CANADA WITHOUT REGARD TO CONFLICTS OF LAWS RULES. ANY LITIGATION WILL BE BROUGHT EXCLUSIVELY IN the Ocean County, New Jersey AND EACH PARTY CONSENTS TO THE JURISDICTION OF THE COURTS LOCATED THEREIN. SUBMITS TO THE JURISDICTION THEREOF AND WAIVES THE RIGHT TO CHANGE VENUE. EACH PARTY FURTHER CONSENTS TO THE EXERCISE OF PERSONAL JURISDICTION BY ANY SUCH COURT WITH RESPECT TO ANY SUCH PROCEEDING. Your use of the Bulletproof Software may also be subject to other local, state, province, national, or international laws. Except in the case of nonpayment of fees due from You to Bulletproof or Your violation of Bulletproof's rights and Your restrictions as to Bulletproof's Intellectual Property, including without limitation Bulletproof Confidential Information, neither Party may institute any action in any form arising out or in relation to this Agreement more than one (1) year after the cause of action has arisen. Documents may be signed in separate counterparts each of which shall be deemed an original and all of which together will be deemed to be one original. The 1980 United Nations Convention on Contracts for the International Sale of Goods, the United Nations Convention on the Limitation Period in the International Sale of Goods, and the Uniform Computer Information Transactions Act, and any implementations or subsequent revisions thereto, do not apply to this Agreement.
