Installation and Usage Rights

You may install and use any number of copies of the Visualization for use with a product or service that supports the Power BI visual interface.

License

The Visualization is licensed, not sold. This agreement only gives you some rights to use the Visualization. Gramener reserves all other rights. Unless applicable law gives you more rights despite this limitation, you may use the Visualization only as expressly permitted in this agreement.

You may not

- work around any technical limitations in the Visualization; or
- reverse engineer, decompile or disassemble the Visualization, except and only to the extent that applicable law expressly permits, despite this limitation.

Documentation

If documentation is provided with the Visualization, you may copy and use the documentation for personal reference purposes.

Restrictions

You agree not to, and you will not permit others to:

license, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the Application or make the Application available to any third party.

Applicable Law.

a. United States.
